

Contest Rules

ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY.
VOID WHERE PROHIBITED.

1. Eligibility

The Livina Press Writing Contest (the “Contest”) is open to legal residents of the fifty (50) United States and District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Livina Press, LLC and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor.

The Contest is sponsored by Livina Press, LLC.

3. Agreement to Official Rules.

Participation in the Contest constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

4. Contest Period.

The Contest begins April 1, 2024 at 12:00am Central Time (CST) and ends May 30, 2024 at 11:59pm Central Time (CST). Entries that are submitted before or after the Contest Period will be disqualified and the entry fee refunded. Submissions will be accepted for the duration of the contest using the submission form on the writing contest page (www.livinapress.com/writingcontest).

5. How to Enter.

Online: This method of entry will be available by visiting our website (www.livinapress.com/writingcontest) and following the directions provided to fill out the entry information and submit.

Limit one (1) entry per person, per email address, and per household for the duration of the Contest Period. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void.

6. Prize Drawing.

On or about June 15, 2024, the Sponsor will select potential winners from all eligible entries received. The Sponsor will attempt to notify the potential winners via email on or about June 20, 2024. If the potential winners cannot be contacted within forty-eight (48) hours after the date of the first attempt to contact them, the Sponsor may select an alternate potential winner in their place from the remaining non-winning, eligible entries.

7. Winner Notification.

The potential winner(s) will be notified by email. Each potential First Place, Second Place, and Third Place winners will be required to complete, electronically sign, and return a Declaration of Compliance within five (5) days of the date notice, or attempted notice, is sent in order to claim their prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period, or the prize is returned as undeliverable, the potential winner forfeits the prize. Potential winners must continue to comply with all terms and conditions of these official rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner from among all remaining eligible entries. Prizes will be fulfilled approximately 2-8 weeks after the conclusion of the contest.

9. General Conditions.

In the event that the operation, security, or administration of the Contest is impaired in any way for any reason, including, but not limited to fraud, virus, bug, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may, in its sole discretion, either (a) suspend the Contest to address the impairment and then resume the Contest in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Contest and, in the event of termination, award the prize from among the eligible, non-suspect entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.
